- gastrointestinal (G-I) upset such as nausea, vomiting, or diarrhea
 respiratory symptoms, such as runny nose or sinus congestion
 unusual or unexplainable fatigue
 muscle pains or body ache not attributed to exercise

- · loss of sense of taste and/or loss of sense of smell

I agree and affirm that I will not attend any Event hosted by M.E.N of CO if I have knowingly been exposed to or in contact* with anyone who has experienced any of the above symptoms within 10 days of any Event. *"In contact" is defined as being within 6 feet or closer for 15 min or longer with an infected person within a 24 hr. period OR having direct contact with fluids from a person with COVID-19. I agree and affirm that I will not attend any Event hosted by M.E.N of CO if I have had a positive test for or symptoms of the SARS-CoV-2 or monkeypox viruses within 14 days of the Event.
